New Delhi Municipal Council proposes to fill up One (01) Post of Architect in the Pay Level – 11 under 7th CPC, on deputation basis initially for a period of 03 years as per extant guidelines of DoP&T. The eligibility criteria required for the aforesaid posts are as under:

1. Officers under the Central/State Govt. having following:

Essential Qualification:

- i. Degree in Architecture/or in Town Planning of a Recognized University or equivalent.
- ii. About 5 years experience in the profession qualification relaxable Committee's discretion in case of candidate otherwise well qualified.

Desirable Qualification:

- i. Association ship of Institute of Town Planner/Architects in India or equivalent.

Period of deputation including period of deputation another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Govt. shall ordinarily not exceed five years. The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of application.
