Vacancy Circular

Sub: Filling up the 02 posts of Deputy Architect in New Delhi Municipal Council on deputation basis in the Pay Level – 10 in 7th CPC

New Delhi Municipal Council proposes to fill up Two (02) Posts of Deputy Architect in the Pay Level – 10 under 7th CPC, on deputation basis initially for a period of 03 years as per extant guidelines of DoP&T. The eligibility criteria required for the aforesaid posts are as under:

1. Officers under the Central/State Govt. having:

Essential Qualification:

- i. A degree in Architecture from Recognized University or equivalent.
- ii. About 5 years experience in the profession

2. Period of deputation including period of deputation another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Govt. shall ordinarily not exceed five years. The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of application.
